Election Day registration is offered for each election, however, registration prior to the election is recommended. To register, you must be a US Citizen, 18 years old on election day, residing in this state and in the county for 30 days prior to Election Day. Re-registration is required if you have moved, had a name change, or if you failed to vote at any primary or general election in the past 4 years. Pre-Registration closes 25 days prior to an election. To register online go to https://idahovotes.gov. You must have an Idaho driver's license or identification card to complete the online voter registration process. If you don't have a driver's license or identification card issued by the Idaho Department of Motor Vehicles you will need to register to vote in person or by mail. You need to complete and sign a paper Voter Registration Application and submit the completed card to your County Clerk's office by mail or in person. If mailed, your registration application must be postmarked by the 25th day prior to an election. To register at the polls on election day, you must provide proof of residence by showing a current Idaho driver's license or Idaho ID card with current residence address or a current picture ID card (Costco card, Student ID card, etc) and any document (utility bill, bank deposit slip, credit card billing, etc) which contains a valid current address. To vote in Idaho, you must present an Idaho driver's license or photo ID card, or US passport or Federal photo ID card, or tribal photo ID card, or a current student photo ID, or if none of the above are available, the voter must sign a Personal Identity Affidavit. 2018 ELECTION DAY INFORMATION

Notice of an election will be published in the legal section of one newspaper in the county at least twice. Each notice will provide the date of election, polling place in each precinct, and the hours polls shall remain open for voting.

AUGUST 28 • NOVEMBER 6 (GENERAL ELECTION)****ABSENTEE VOTING**

Application for an absentee ballot: (you must be registered to vote in Idaho to request an absentee ballot). If you wish to have an absentee ballot mailed to you, the request must be received by the county clerk's office 11 days prior to the election. You may cast an absentee ballot in person at the absent elector's polling place (usually the county clerk's office) no later than 5 p.m. the Friday before the election. The County Courthouse is the polling place for all absentee voting for schools and all taxing districts, city, county, state and federal elections. Written requests are to be mailed to: Election Officer, P.O. Box 896, Lewiston, Idaho, 83501 or (208) 799-3020.
